Course Description

Survey of psychoactive drugs, including prescription and street drugs; social, behavioral, and physiological effects of drugs; neural mechanisms of drug action; history of drug use.

Warning: This class discusses drug use in detail. Those with prior or current drug problems should be aware of this and consider whether exposure to these discussions may serve as triggers for cravings for drug use and possible relapse. If so, you may wish to consider dropping the course. Your instructor is not responsible for any adverse reactions to the course material.

Course Goals and Student Learning Outcomes (CLOs)

Upon successful completion of this course, PSYC/PH 126 students will be able to:

1. Describe the history of drug regulation in the United States, including bringing a drug to the marketplace.
2. Be able to classify drugs according to their legal status and drug class.
3. Be proficient in describing the actions of drugs in the brain and body.
4. Be able to describe the behavioral and psychological effects of drug classes, in general, and specific drugs, in particular.
5. Be able to identify the genetic, personality, social, and environmental factors leading to substance abuse as well as effective drug abuse treatment options.

Program Learning Outcomes (PLOs)

Upon successful completion of the psychology major requirements, students will be able to:

PLO1: Knowledge Base of Psychology- Students will be able to identify, describe, and communicate the major concepts, theoretical perspectives, empirical findings, and historical trends in psychology.

PLO5: Values in Psychology- Students will value empirical evidence, tolerate ambiguity, act ethically, and recognize their role and responsibility as a member of society.

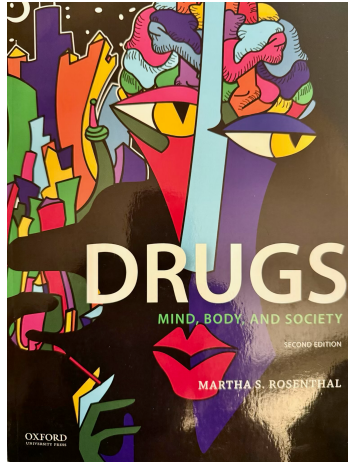

Major Assignments

Reading Response

For each chapter, you will write a one-page (~250-word) reaction. You should focus on the 2-3 ideas that stood out most from the readings. Reading Responses are required for most of the chapters we cover, but not all; keep an eye on Canvas.

Literature Review Project: In the first half of the semester, you will choose a course-relevant topic you're curious about and use a recent review article to build a knowledge base. You will then write a 5-page literature review that synthesizes peer-reviewed research (5-6 articles) from the past 10 years and critically evaluates the evidence, including key strengths, limitations, and current approaches and protocols. Detailed instructions and grading criteria will be posted on Canvas.

Topic Flash Talk

You are to prepare a 3-minute flash talk based on your literature review. This assignment is designed to help you communicate research findings to a general audience using succinct,

accessible language. Your presentation will be an elevator pitch (4 slides) that introduces the research topic and summarizes your findings from your literature review. Your goal is to promote understanding and interest in this topic among individuals who may not be familiar with it. Therefore, being concise, clear, and accessible is essential for this presentation.

Documentary Review

You are to choose a documentary on a topic of interest relevant to [Kanopy Streaming](#). You will need to sign in to your MySJSU account to access Kanopy. Your review will be a one-page response paper. What did the documentary get right? Was any misinformation presented? Did the documentary have an agenda? What did you learn? Wrap up your one-page review with a summary statement!

Test and Quizzes

There will be open-book, note quizzes on chapter content to be completed in Canvas. Quizzes are an opportunity to check your knowledge. All students will have two opportunities to take each quiz. There will be one cumulative test at the end of the semester. The test requires the use of Lock Down Respondus.

On four occasions during the semester, we will have an activity based on class material that will be completed and submitted on the Sunday of the activity week.
